# ANNUAL REPORT ON THE ACTIVITIES OF KARIN DOM FOUNDATION FOR 2022

In 2022, Karin Dom Foundation continued to fulfill its mission of working for the full development and growth of children with special needs in their families, for their successful inclusion and increasing tolerance in society.

The Foundation is managed by a single-tier management system, including:

- Management Board

The foundation is represented jointly and separately by Georgi Vasilev Bogdanov and Borislava Ivanova Cherkezova.

Here are some important highlights of the Foundation's activities for 2022.

## Social services

In 2022, Karin Dom Foundation operated with a license for 6 social services from the Agency for Quality of Social Services, which were used by a total of 939 families with children from the city, the region and the country, including refugees from Ukraine.

The team of the Centre for Social Rehabilitation and Integration provided social services to 721 families: 196 families were involved in therapeutic and social work (through 3955 therapeutic sessions and 1553 social consultations, 63 one-time consultations and 23 one-week packages). Integration activities were provided to 525 Ukrainian children, who were refugees from the war.

The Early Intervention team consulted 192 families (714 home visits) out of which 94 children from the region and 46 families of newborn babies from the community supported by the Baby Box project under the Karin Dom on Wheels project.

Montessori house provided services to 26 children.

The palette of social services was expanded with new activities - adapted swimming in the pool, Montessori group for children with special needs from 6 to 9 years old. The occupational therapy activity was expanded, as was the community work with children from the region and refugees.

The upgrading trainings of the team continued using various methods and approaches, the most extensive being the Bobath approach, with tutors from the Belgian Bobath Association, where 9 physical and speech therapists from Karin Dom participated. Training of psychologists started in preparation for the expansion of diagnostic work with children. The training of professionals and children to use the eye tracking assistive technology as part of the therapeutic work is being extended.

#### **Training activity**

In 2022 Karin Dom training center held 176 training events with a cumulative number of 2039 participants, of which 1465 were unique participants. The following trainings were conducted:

- Project based trainings to 614 specialists from the educational system and social services, needs assessment of the staff of 7 family-type child care homes and the first supervisions were carried out.
- 3 open trainings were held with 33 participants.
- 9 trainings were held with 127 participants, upon request, on topics such as "Application of the Ages and Stages Questionnaires ASQ-3 and ASQ&SE", "Sensory-motor activities", "Innovative methods and approaches in working with children with SEN", "Specifics in the education of children with special needs", "Application of the Montessori method in working with children with SEN", etc.
- During the year, 55 students and interns visited Karin Dom and participated in internship programs.

In October, Karin Dom organized a conference on the topic "Support and partnership in inclusion" with 165 participants. During the conference, we shared the outcomes of our work on the Transfer of Practices project, Karin Dom - the next 20 years project and the Additional Support and Mediated Learning in Inclusive Education (ASUMIE) project. In addition to the therapists and trainers from Karin Dom, our partners from Iceland, Belgium, Italy, Portugal and Norway, parents, representatives of the Ministry of Education and Science, Sofia university and partners from the country were speakers at the conference.

We added two new programs for qualification of pedagogical specialists approved by the Ministry of Education and Science - "Development of an individual support plan with the participation of specialists, parents and community services" and "Creative therapies in support of inclusion".

### Communication and social networks. Projects.

An automated digital email and LinkedIn campaign was carried out with the financial support of a project with the AGORA Platform Association (Active Civil Communities for the Development of an Alternative) within the framework of the Development of Charity at the Local Level Program under a grant of America for Bulgaria Foundation.

The good perception of the campaign and the interest shown by the contacted companies is impressive. As outcomes of the campaign, we can share about specific inquiries and donations in favor of Karin Dom, as well as an interest for additional information and future meetings.

The regular sending of press releases to the media continued. Karin Dom's media contact list is being updated regularly. After a charity event held in April at the British Embassy in Sofia, our list of national media and new partners expanded.

In 2022, a competition was held for the rebranding of the Karin Dom logo, which is to be protected as a trademark.

In 2022, we submitted 16 project and initiative applications, most of which have been approved.

Work on the new projects gave Karin Dom the opportunity to expand its activities and enrich the offered services with new activities. The financing allowed to provide:

- upgrading trainings for the team,
- second work visit to Iceland,
- a round table in Sofia to present the results of the project and make recommendations for changing practices and policies in the educational system in Bulgaria,
- participation in an International Conference on the topic of Alternative and Augmentative communication,
- organization of various events: for sharing experience and partner meeting in Milan under the ASUMIE project, Regional conference on donation and intersectoral cooperation.

### Advocacy

Karin Dom's advocacy activities include informing the public about innovations in social services, policies for children, sharing experience and good practices in family counseling, in the therapy of children with special needs, and in early childhood education methods. Karin Dom is a member in various expert and civic councils such as the Council for the Development of Civil Society, the National Council of the State Agency for Child Protection, the Council for Social Services at the Municipality of

Varna, the National Alliance for Children, the Alliance for Early Childhood Development, EASPD, etc.

Charitable events were organized to promote the activities and expertise of Karin Dom and for fundraising purposes. The specialists from Karin Dom actively participated in public councils and expert working groups, giving opinions and recommendations on the preparation of legislative documents and national policies.

In 2022, Karin Dom received several significant awards for its activities:

- Forbes Award for Innovation,
- First place for the Building of the Year 2022 from the Golden Plumb regional competition of Bulgarian Construction Chamber Varna.

#### New building

On September 19, 2022, the new building of Karin Dom was officially opened. This happened thanks to several months of joint efforts of the team, donors, partners and volunteers. The successful implementation of this project is due to the cooperation of the municipality of Varna for a donated plot. The construction of the new center, equipment and furnishings took place through 2018 project funding from Velux Foundations, as well as the support of many socially responsible corporate donors and active citizens.
